

Subjects Individuals with developmental disability* registered in accordance with the Act on Welfare of Persons with Disabilities

Coverage

- (Regional Hub Hospitals) Systematic medical support tailored to the characteristics and needs of individuals with developmental disabilities

Developmental Rehabilitation Service Initiatives

Subjects Children under the age of 18 with visual, hearing, speech, linguistic, intellectual, autism spectrum, or brain lesion disabilities*

* However, for children under the age of 9, a referral and medical evaluation indicating a likely disability and need for services may be accepted in place of a formal registration of disability.

Coverage Provision of developmental rehabilitation services including speech and hearing therapy, art and music therapy, behavioral therapy, play therapy, psychological rehabilitation, sensory integration therapy, motor skills therapy, and psychomotor rehabilitation

Amount of Subsidy Coverage differentiated according to household income

Grade of income	Amount covered (Personal expense)

Aid of Medical Fees for Adopted Children with Disabilities

Subjects

- Children determined to be eligible for Child Care Assistance Payments for Disabled Children.

Selection Criteria

- Eligible children with disabilities
 - Children registered as disabled in accordance to Article 32, Paragraph 1 of the Act on Welfare of Persons with Disabilities at the time of adoption
 - Children suffering from a medical condition at the time of adoption from birth complications such as premature birth, low birth weight, or hereditary conditions
 - * If a child who received financial aid for the aforementioned birth complications fully recovers, the aid will be discontinued.
 - Children adopted with undiagnosed congenital conditions who have later been registered as disabled or diagnosed with a disability
 - * Criteria for determining whether a child with a medical condition is eligible for financial aid: Determined in consultation with a university hospital-level specialist, based on a medical certificate (or diagnosis) appropriate to the condition.
- Financial aid is provided until the age of 18 for those who meet the above criteria. Full payment will be given for the month in which the support ends.
- For those enrolled in a school (excluding students on leave of absence) under Article 2 of the Elementary and Secondary Education Act, financial aid is provided until graduation (Proof of enrollment must be attached).

Coverage

- Personal expenses (including covered and non-covered services) spent for medical counseling, rehabilitation, and treatment (including psychotherapy) within 2,600,000 KRW per year
- Coverage includes medical fee claims for assistive devices for people with disabilities (effective Jan. 1, 2013).
 - However, aid for medical expenses related to assistive devices shall not exceed 50% of the annual budget allotted for the financial aid.

Aid of Medical Fees for Individuals with Disabilities

Subjects

- Individuals with a registered disability eligible for Medical Assistance Program, Type 2 under the Medical Benefit Act
 - Individuals with a registered disability from a work-capable household eligible as a recipient under the National Basic Living Security Act
 - Disability-related medical expenses are covered only for the individual with a registered disability; non-disabled family members in the same household are not eligible.
- Individuals with registered disabilities (including chronically ill and disabled children under 18 years of age) who qualify for the second-lowest income bracket deductible reduction under the National Health Insurance Service

Coverage

- Financial aid for personal expenses incurred by eligible individuals when visiting healthcare institutions

Application

- Eligible individual must present the Welfare Card for Persons with Disabilities at the healthcare institution.

Therapy Support Services for Special Education Students

Subjects

- Individuals identified as eligible for therapy support among those receiving special education.

Selection Criteria

- Diagnosis and assessment are conducted for special education students seeking treatment, and those eligible for treatment support are selected.

Coverage

- Provide physical therapy, occupational therapy, and other services through therapist recruitment, vouchers, and treatment support providers (hospitals, clinics, disability welfare centers, private practices, etc.)

Application

- Therapy support applications are available upon selection as a special education student.
- Applications are open to special education students in elementary, middle, and high schools, as well as special schools, who wish to receive therapy support services.

Respite Program for Families with Developmental Disabilities

Subjects Individuals with developmental disabilities (intellectual and autistic)* or family members of individuals with developmental disability

* Children under the age of 9 may apply using a doctor's note (medical diagnosis) or a referral for developmental rehabilitation services issued by a hospital within the past 6 months, even if not registered as disabled.

Contents

- Healing Camps: Relaxation activities such as family bonding, awareness programs, and peer counseling
- Themed Trips: Focused on historical and cultural experiences, or visits to institutions
- Self-Guided Trips: Trips planned independently by families

Coverage Cost covered per participant*

- * Maximum payments: 75,000 KRW for one day, 150,000 KRW for one night and two days, and 240,000 KRW for two nights and three days
- * Participants are responsible for any costs exceeding the amounts covered.

Parent Education Support Program for Parents of Individuals with Developmental Disabilities

Subjects Parents or guardians of registered individuals under the age of 9 with intellectual disabilities or autism spectrum disorders; parents and guardians of infants and children with delayed development; and professionals in related fields

Coverage

- Standard Type: Offers information on developmental disabilities across the life cycle and nurturing skills
- Self-Directed Type: Provides community-specific, in-person parent education
- Self-Help Group Type: Facilitates self-managed parent education tailored to the participants' needs

Counseling Support Program for Parents of Individuals with Developmental Disabilities

Subjects Parents and guardians of children registered with intellectual or autism spectrum disabilities in accordance to the Act on Welfare of Persons with Disabilities

- * Includes individuals with intellectual or autism spectrum disabilities as a secondary disability
- * Parents of children with developmental disabilities may also apply*
- * However, while priority is given to parents, if a parent is unable to reside with the individual with a developmental disability, a guardian (within two degrees of kinship) who lives with and provides care for the individual in stead of the parent may be considered eligible.

Coverage

- Individual and group counseling for parents and guardians of individuals with developmental disabilities
 - Individual counseling: 50 minutes per session, 4 or more sessions per month / Group counseling: Approximately 100 minutes per session, 3-4 sessions per month
- If both parents receive individual counseling or if couple counseling is provided as needed, the service is assumed as having been provided to only one person.
- If the couple receives counseling together as a group, the group counseling rate (for 2 participants) is applied.

Amount of Subsidy 50,000 KRW per application(40,000 KRW government subsidy*, up to 10,000 KRW of personal expenses)

* Monthly government voucher: 160,000 KRW

Personalized Support Plan for Individuals with Developmental Disabilities

Subjects Individuals with developmental disability (intellectual disability and autism)

* Children under the age of 9 do not need to be registered as disabled to apply. However, a doctor's note (medical diagnosis) or a referral for developmental rehabilitation services issued by a hospital within the past 6 months must be submitted.

Coverage Development of individualized service support plans and coordination of service connections to ensure that individuals with developmental disabilities receive care tailored to unique characteristics and needs.

Application Application at administrative welfare centers (local community centers) or developmental disability centers ► Consultation with National Center For Developmental Disabilities ► Individualized support plan meeting ► Eligibility screening (municipal offices: si, gun, gu) ► Notification of results ► Referral and connection to services based on the individualized support plan ► Monitoring

* Government employees (social workers) and staff at National Center For Developmental Disabilities may apply on the individual's behalf.

Support Center for Childcare Counseling Program (infants, parents, and teachers)

Subjects Parents (or caregivers) of preschool-age infants and children, and staff in childcare and education

Coverage Through counseling by Support Center for Childcare, it provides enhanced nurturing skills for parents and childcare staff, along with psychological and emotional support to foster a positive childcare environment.


- Parents: Information on infant and toddler development, managing problematic behaviors, age-specific parenting guidance, parenting attitude and stress, psychology, emotions, and more
- Infants and Children: Health and development, social interactions, temperament, psychology, and more
- Staff in Childcare and Education: Mutual interactions, stress management, psychology and emotions, temperament, and more

* Professional testing tools to be used when necessary
 * Operation and content of the program may vary by the Support Centers for Childcare

What is Support Center for Childcare Counseling Program?

This program provides field-specific analysis of challenges related to nurturing and childcare, such as infant and toddler development, problematic behaviors, childcare environment, and stress experienced by parents and childcare staff, as well as appropriate support strategies.

Support Program for Extensive Developmental Assessments of Infants and Children

Subjects Individuals insured through National Health Insurance and eligible medical benefit recipients assessed as “Detailed Assessment Recommended” in accordance to the Korean Developmental Screening Test for Infants & Children (K-DST)

Korean Developmental Screening Test (K-DST)

Infant and toddler medical examinations from the 3rd to 8th sessions evaluate six developmental areas (gross motor skills, fine motor skills, cognition, language, social skills, and self-help) by each month.

- Each area is assessed and categorized as: “Normal”, “Follow-up Examination Needed”, “Detailed Assessment Recommended”, or “Constant Management Required”.

Coverage Personal expenses for tests and consultations directly required to diagnose a developmental disability(including statutory deductibles and non-reimbursed costs).

* Excludes treatment costs, disability certification fees, and differences of premium ward charges.

Amount Covered

- Beneficiary of National Basic Livelihood (Medical, Housing, Living), Lower Income Families: Up to 400,000 KRW

- National Health Insurance Members: Up to 200,000 KRW

* Financial aid provided based on the eligibility at the time of application

Application Period

Infants and children who have completed the 3rd to 8th rounds of the infant and toddler health screenings this year shall undergo a detailed developmental assessment for infants and children within one year from the date of the corresponding health screening and submit their application by the first half of the following year (by the end of June).

* If detailed assessment is completed in 2025, applications may be submitted until the end of June 2026.

Procedure

Bring the notification letter of the infant and toddler health screening results and have a detailed examination conducted at a designated or preferred testing institute.

* When visiting a designated testing institute, an “Confirmation of Eligibility and Request Form for Detailed Developmental Assessment of Infants and Children” is required. This form can be issued by the local public health center.

Required Document

Notification letter of the results of Health Screening for Infants and Children

Developmental Support Service for Infants and Children

Subjects Infants and children within the region and their guardians, daycare centers, and childcare staff

Coverage Early detection, intervention, and appropriate support for infants and children with developmental delays to help promote healthy development and enhance the quality of life for families

* Operation and content of the program may vary by the Support Centers for Childcare

- (Support for Infants and Children)

① Observation and identification of infants and children with developmental delays, and analysis of underlying causes through screening tests (e.g., K-DST)

② Promotion of healthy development through in-depth evaluations and tailored support based on each child's level and characteristics (such as referrals for treatment support, counseling, and relevant information)

- (Support for Parents) Psychological support and enhancement of parenting skills tailored to each child's characteristics through parent education, counseling, and access to relevant information on child development and parenting

- (Support for Teachers) Systematic support to help educators apply developmentally appropriate teaching methods through teacher training, developmental counseling, and related services

What is Developmental Support Service for Infants and Children?

Developmental Support Service for Infants and Children is a service which identifies infants and children at risk of developmental delays through observation and assessment, analyzes the underlying causes, and provides tailored support to promote healthy development and prevent potential disabilities.

Childcare Support for Children with Disabilities

Subjects Children with disabilities who are not enrolled in school and hold a Disability Welfare Card (registration card) at 12 years of age or younger

- However, support may also be provided for the following cases:

- * Children aged 3–5 years who have been selected for special education under Article 15 of the Act on Special Education for Persons with Disabilities and have submitted a notice of diagnosis or evaluation of eligibility for special education
- * Children aged 5 years or younger not in possession of a Disability Welfare Card, a notice of diagnosis or evaluation of eligibility for special education, who submitted a doctor's note verifying the disability.
- * Childcare support is available even if a child with a disability is unavoidably on leave from school (ages 6–12 years for those with a Disability Welfare Card; and ages 6–8 years for those who submit a notice of diagnosis/evaluation results for special education)
- * Children with disabilities who have reached school age but cannot attend general elementary or special schools due to illness or other reasons are eligible for free childcare, provided they have a Disability Welfare Card or submit a notice of diagnosis/evaluation results for special education.
- * Children with disabilities attending government-supported special schools (kindergarten or elementary) are not eligible for free childcare support; however, elementary school students qualify for after-school childcare support.
- * Children receiving special education are eligible for after-school childcare support until 8 years of age.

Selection Criteria

- Application is available regardless of income level of the parents or guardians. However, applicants must submit one of the following: a Disability Welfare Card (registration certificate), a doctor's diagnosis of disability, a special education student diagnosis, or a notification of evaluation results.

Coverage Childcare support for daycare use

Amount of Subsidy

- Child in a disability class: 587,000 KRW
- Child in Nuriban (disability class) aged 3–5 years old: 587,000 KRW
- Children with disabilities in non-disabled classes: Age-specific childcare payment limit announced by the city or provincial government

Childcare Support For Families with Disabled Children (Care Services)

Subjects Families living with a severely disabled child registered under the Act on Welfare of Persons with Disabilities who is under 18 years of age.

Coverage

- Visits of trained caregivers to provide at-home care services, including learning activities, play, hygiene support, and outings.
- Up to 1,080 hours of care services are supported per year (up to 160 hours per month)*
* However, if a gap in care arises due to a parent or guardian's absence related to a legally defined infectious disease, rehabilitation, or school closure, the monthly limit of 160 hours may be exceeded (with submission of a statement of reason).

Amount of Subsidy Free for families of 120% or less of the standard median income; families over 120% of the standard median income shall copay 40% of the fee.

Subjects Families* of children with disabilities under the age of 18

Financial Aid for Childcare of Adopted Children with Disabilities

Subjects

- Families domestically adopting children with disabilities by an adoption agency licensed under the Act on Special Cases Concerning Adoption in accordance with the requirements and procedures of the law.

Selection Criteria

- Eligible children with disabilities
 - Children registered as disabled in accordance to Article 32, Paragraph 1 of the Act on Welfare of Persons with Disabilities at the time of adoption
 - Children suffering from a medical condition at the time of adoption from birth complications such as premature birth, low birth weight, or hereditary conditions
 - * If a child who received financial aid for the aforementioned birth complications fully recovers, the aid will be discontinued.
 - Children adopted with undiagnosed congenital conditions who have later been registered as disabled or diagnosed with a disability
 - * Criteria for determining whether a child with a medical condition is eligible for financial aid: Determined in consultation with a university hospital-level specialist, based on a medical certificate (or diagnosis) appropriate to the condition.
- Financial aid is provided until the age of 18 for those who meet the above criteria. Full payment will be given for the month in which the support ends.
- For those enrolled in a school (excluding students on leave of absence) under Article 2 of the Elementary and Secondary Education Act, financial aid is provided until graduation (Proof of enrollment must be attached).

Coverage

- Adopted child with a severe disability: Childcare subsidy of 721,000 KRW per month
- Other eligible individuals including adopted children with less severe disabilities: Childcare subsidy of 634,000 KRW per month

Allowance for Disabled Children

Subjects A registered person with a disability under the age of 18 who receives livelihood, medical, housing, or education subsidies and falls within the second-lowest income bracket.

Coverage Financial aid to enhance the quality of life for children with disabilities

Amount of Subsidy

- Children with severe disabilities (severe disabilities)
 - Eligible recipient of National Basic Living Security livelihood or medical subsidies: 220,000 KRW per month
 - Eligible recipient of National Basic Living Security housing or education subsidies and those fall within the second-lowest income bracket: 170,000 KRW per month
 - Beneficiary of livelihood security facility (livelihood, medical): 90,000 KRW per month
- Children with mild disabilities (mild disabilities)
 - Eligible recipient of National Basic Living Security livelihood or medical subsidies: 110,000 KRW per month
 - Eligible recipient of National Basic Living Security housing or education subsidies and those fall within the second-lowest income bracket: 110,000 KRW per month
 - Beneficiary of livelihood security facility(livelihood, medical): 30,000 KRW per month

Support Program for Infants and Children with Disabilities

Subjects Daycare centers and childcare staff within the region

Coverage Provision of structured and systematic teaching methods through training, guided visits, workshops, and other programs related to the care of infants and children with disabilities (inclusive childcare)

* Operation and content of the program may vary by the Support Centers for Childcare

- (Training and Counseling): Training and counseling to strengthen competencies in areas such as writing IEPs, teaching strategies, and using educational diagnostic tools
- (Consulting): Customized consulting for developmental support, including childcare environment assessment and interaction guidance
- (Childcare Center Visitation Support): Experts visit childcare centers to provide tailored support services based on the institution's characteristics (e.g., therapy sessions, counseling, level-based interventions)

Support Program for Infants and Children with Disabilities (Childcare Services for the Vulnerable Support Program)

This program offers training, counseling, and consulting to childcare teachers and centers responsible for caring for infants and children with disabilities. Its goal is to strengthen the professional capacity of childcare staff to:

- ① establish a cohesive and high-quality service system;
- ② create an environment where parents can confidently and safely entrust their children



Support Program for Linguistic Development

Subjects

- (Eligible Individuals): Non-disabled children under the age of 12 whose single parent or one grandparent (in households where grandparents are the primary guardian) is a person with a registered visual, hearing, speech, intellectual, autism spectrum, or brain lesion disability
- (Income Criteria): At or below 120% of the standard median income (Level of support varies by income level)

Coverage Provision of speech and linguistic rehabilitation services, including language and listening skills therapy, reading lessons, and sign language lessons

* Subject-specific lessons or study materials, such as essay writing or general study guides, is not included.

Amount of Subsidy The amount provided is determined according to the eligible individual's income, as listed below:

Income level	Amount covered (Personal expense)
Beneficiary of National Basic Livelihood	220,000 KRW per month (personal expense waived)
Second-lowest income bracket	200,000 KRW per month (personal expense 20,000 KRW)
65% or below the standard medium income	180,000 KRW per month (personal expense 40,000 KRW)
Between 65% and 120% of the standard median income	160,000 KRW per month (personal expense 60,000 KRW)

Emergency Care Service for People with Developmental Disabilities

Subjects

- Individuals aged 6–65 years with developmental disabilities (intellectual and autism spectrum disorders) and their families

Coverage

- Daytime activities and overnight care for individuals with developmental disabilities for up to seven days under a temporary care plan tailored to their needs and characteristics, when their guardian is unable to provide care due to emergencies (medical treatment or hospitalization, family events, psychological burnout, etc.)
 - Available up to 30 days per year
 - Re-entry available after 15 days

Usage Fee

- 30,000 KRW per day (15,000 KRW for use + 15,000 KRW for food*)
 - * Food costs 10,000 KRW per meal, totaling 30,000 KRW per day (15,000 KRW co-payment + 15,000 KRW government subsidy)

After-School Services for Youth with Developmental Disabilities

Subjects

- Individuals aged 6–18 with intellectual or autism spectrum disabilities registered in accordance to the Act on Welfare of Persons with Disabilities
 - However, individuals over the age of 18 should choose between the after-school activity service (certificate of enrollment* required) and the basic type of daytime activity service as these services cannot be used simultaneously.

* Only certificates of enrollment issued within the past month are accepted.

- Variety of programs for small groups of 2 to 4 participants, including hobbies, experiential activities, and preparation for independent living

- Available Monday to Saturday, from 9 AM to 9 PM (66 hours per month)

Subjects Individuals aged 18–65 with developmental disabilities (intellectual and autism spectrum disorders)

Coverage Daytime activities and safe housing support for individuals with profound developmental disabilities

- 24-hour individualized 1:1 support: Monday to Friday (24-hour service)
 - * Service on Fridays is available until 8 PM
- Weekly individualized 1:1 support: Monday to Friday (10 AM–5 PM)
- Weekly group 1:1 support: Monday to Friday (9 AM–6 PM)
 - * Up to 176 hours per month, up to 8 hours per day
